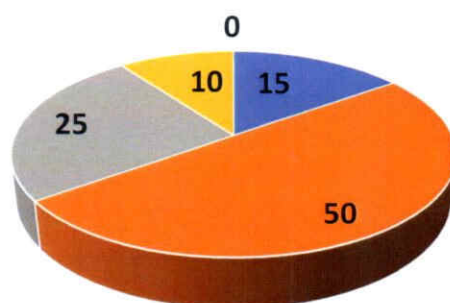

Summary of student feedback analysis:

- 100% of the students were highly satisfied with opting pharmacy course and majority of the students were found satisfactory and rated excellent and very good with respect to relevance of curriculum and syllabus to the course.
- Though majority of students rated very good and good for teaching aids in the class by faculty to facilitate teaching, there are suggestions to present power points for readability and effective learning with insertion of videos to live concepts. IQAC has noted the same and proposed to implement same in fore coming classes wherever necessary.
- With respect to electives in terms of relevancy to the curriculum, 30% of students are unsatisfied, as need more innovative methodologies in syllabus to meet the real time needs and we have putforth the same in IQAC minutes.
